

Privilege List

This Document (Privilege List) describes Privileges, receiving by the Member and procedure of its provision by the **Bravia Inversiones y Gestiones, S.L** (“Company”).

1. The following list of Privileges are provided:
 - Access to special event organized by the Company
 - Latest Apple or Samsung Phone model released (“Phone”)
 - Nespresso Essenza Mini Black coffee machine
 - Payment of mobile services on behalf of Member
 - Payment of insurance premiums on behalf of Member

2. Member receives special club card, that confirm the Member’s right to visit events organized by the Company free of charge, after the payment of Joining fee. Company shall notify member about future events no later than 1 month prior to such event. Member agrees that Member shall bear all expenses connected with Member’s travel to and occupancy at place where event take place, unless otherwise is provided in Company’s notification.

3. The Member shall make an additional Club fees to receive other Privileges. Amount of such Club Fees are specified in account of the Member at bravia.club Website.

4. The Phone is provided to the eligible Member on the basis of Accompanying Agreement upon request of Member sent at website bravia.club for the Term of Membership. Provided however, the Member has the right to exchange the received Phone for a new model, in the case of automatic renewal of the Agreement for a new term, in accordance with section 16 of Agreement. The Company shall send the Phone by post or courier to the address specified by the Member at Bravia.Club, within 5 working days from the date of signing of Accompanying Agreement by the Member. Member must submit all claims for the quality of the provided Phone to the manufacturer of the relevant Phone. In the event of termination of the Agreement, Accompanying Agreement shall also be considered terminated and Member agrees to return the Phone to the Company within 30 days from the date of termination notice.

5. The Nespresso Essenza Mini Black coffee machine is provided to the eligible Member on the basis of Accompanying Agreement upon request of Member sent at website bravia.club for the Term of Membership. The company undertakes to send the coffee Machine, as well as 50 capsules for this coffee machine, by mail or courier to the address specified by the Member at Bravia.Club, within 5 working days from the date of receipt of the Member’s request. Member must submit all claims for the quality of the coffee Machine to the manufacturer. In the event of termination of the Agreement, Accompanying Agreement shall also be considered terminated and Member agrees to return the coffee machine to the Company within 30 days from the date of termination notice.

6. The Member entitled to receive the Privilege in the form of payment for mobile services on behalf of Member undertakes to switch to the tariff chosen by the Company from the operator chosen by the Company. The Company undertakes to make monthly payment for such tariff in the amount established by the operator. Provided however, the Company is not responsible for other expenses of the Member related to the use of mobile services. In case of the Member's mobile payment debt within 30 consecutive days, which is not connected with the Company's non-payment of the chosen tariff in the relevant month, the Company is entitled to send request on blocking such SIM-card to operator. The Member acknowledges and agrees that the Company is entitled to deduct an amount of any damages incurred by the Company in connection with such Member's debt from amount of Joining fee.
7. A Member who is entitled to receive a Privilege in the form of payment of insurance premiums must conclude an insurance contract specified by the Company with an insurer specified by the Company. After the conclusion of the relevant insurance contract with the insurer specified by the Company, the Member must inform the Company about this insurance contract, including the number and date of the insurance contract. The Company undertakes to compensate to the Member amount of insurance premiums that is duly payable by the Member at the date of making applicable Club fee. The Member acknowledges and agrees that the Company is entitled to deduct from the amount of Joining fee an amount of such compensation in case that the Member early terminate the Agreement.
8. The Company is entitled to make any changes, amendments or alterations to this Document without prior written consent of the Member.
