

Terms and conditions of Bonus program of Bravia.Club

The following terms and conditions of Bonus program of Bravia.Club (“Terms and conditions”) developed by **Bravia Inversiones y Gestiones, S.L.**, a company incorporated in Spain (“Company”) in purpose of foster Member’s loyalty governs procedure of crediting and transfer of Bonus to Member for Member’s different active actions on the Website.

1. Definitions.

- 1.1. **Account** means an electronic data register, maintained by the Company, containing information about the credited Bonus to the Member.
- 1.2. **Activity** means some active actions, defined by the Company, for which the Member receives Bonus.
- 1.3. **Bonus** means monthly monetary remuneration payable by the Company to the Member for committing an Activity, that calculated on the basis of the total amount of Club fees made by the Member during the Term of Membership and monthly Activity of the Member.
- 1.4. **Member** means natural person signed Terms and Conditions of Bravia.Club Membership by electronic means on the Website.
- 1.5. **Website** means website bravia.club.

2. General provisions.

- 2.1. Member acknowledges and agrees with this Terms and conditions on the moment when sign Terms and Conditions of Bravia.Club Membership.
- 2.2. Member shall bear all fees and commissions connected to transfer Bonus from the Account to any Member’s bank account or account in any payment systems.
- 2.3. The Member acknowledges and agrees that Company is entitled to send technical, information and advertising materials to the e-mail address specified during registration on the Website.
- 2.4. The Company is entitled to offer the following Activities to the Member by sending an e-mail to the e-mail address specified during registration on the Website or by sending a letter to the Member's profile on the website:

- complete a survey;
- click on active links;
- read the articles published by the company and filling quick answers;
- view ads.

- 2.5. The Company shall offer the Member at least 2 Activities within one month.

3. Calculation of Bonus. Transfer Bonus from Account.

- 3.1. Bonus shall be calculated monthly in accordance with information related to monthly Activity of the Member, contained in the account of the Member at website. In order to calculate amount of Bonus, Company will calculate only those Club fees that were made no later than 3 calendar days before the end of the reporting month.
- 3.2. Bonus are credited to the Account no later than 3 working days from the end of the reporting month.
- 3.3. The Member is entitled to withdraw Bonus from the Account to his / her bank account or account in the payment system on the day following the day of crediting Bonus to the Account.

4. Term. Amendments to Terms and conditions.

- 4.1. This Terms and conditions is valid until cancellation by the Company.
- 4.2. The Member acknowledges and agrees that the Company is entitled to to make any changes, amendments or alterations to this Terms and conditions and cancel this Terms and conditions. Member shall send notification about termination of his/her participation in this Bonus program to Company in case that the Member disagree with such changes, amendments or alteration of this Terms and conditions. Member acknowledges and agrees and termination of his/her participation in Bonus program shall not cause termination of Membership.
